-Regional Updates

- -What shows have been cancelled? Rescheduled? Etc.
 - all spring shows and events have been cancelled at this time.
- -Any other Jr. news?
- NEGG has started a youth newsletter which is being head by Sophia Romani.
 She is always looking for material and input!

-Fundraising

- Digital fundraising options? Raffle Items, Prize Calendar, etc.?
- -We discussed clothing and raffle items however we are all concerned with the initial investment of this as we currently do not have the funds available to use.
- World Galloway Conference has vowed to offer us a discounted package for world conference admissions.
- Proposal from Jon B. we would donate one \$500 WGC reservation for a raffle that I am proposing. Most all reservations to date have been for two people/couple so from a marketing stand point I think having a \$1000 value and 2 reservations may be an easier sell. On the second reservation \$500 the Juniors would pay the Society back when the raffle occurred on or around August 1st, 2020. My thought on selling the tickets would be \$10/ chance for (the 2 reservations) times 100 sold would net the Juniors \$500 if you think you can get \$15 or \$20/ chance the profit would be \$1000-\$1500 for the Juniors.
- We are inclined to accept this opportunity however we would like to wait until WGC is fully confirmed and do not want to open ourselves up to having to refund money due to cancellation.

-Foundation Funds vs Youth Funds

- The society has recommended that we need our own bank account to separate funds.
- -We all feel that this is unfair and that there is not anyone that should have individual responsibility to maintain these funds.
- *Motioned* that we request \$2500 as start up funds on an interest free loan to be paid back over a period of time as the funds allow. Funds were improperly

allocated and can not be recounted or traced to the source at no fault of the juniors and feel this is a minimum prerequisite to supporting the national youth show. We further request the society open and be held responsible for a sub account allocated specifically to the National Jr. Show. *Motioned, Seconded & All in favor*

-Virtual Jr. Show

- -Do we offer awards? If so, how do we pay for them? How do we arrange shipping etc?
- Kaye Kaufman has offered to judge the show at no cost, she has judged at both NAILE and Denver in the past.

 - The committee fully supports the idea of a virtual jr. show. Sophia Romani and Dustin James will be co chairs of this project and will be responsible for overseeing the details and entries etc. If sponsorship can be attained we would like to offer prizes for champion and reserve champion winners as well as the marketing video category. Benchmark Graphic, Pine View Farm and Magnolia Trace have all come forward with sponsorships for this event.
