Junior Nationals Director of Breed promotion and Member outreach Corinna Caron detailed preliminary plans to hold the first ever Junior National event in June 2024 in Medina, Ohio. **Motion**; Jack Bagley, Second Victoria Voisine, the Belted Galloway Society support holding this event in June 2024. Motion carried. Unanimous

Journal / Newsletter; Editor Jayde Reilly made a proposal to the council that had already been approved by the advertising and promotion committee chaired by Don Henderson. The proposal would stop monthly editions of the US Beltie News effective December 31, 2023 as well as the annual publication of the Belted Galloway Journal with the 2023 edition. Effective January 1, 2024, the two will be combined into a quarterly publication with the Society handling the advertising income and expense billing, while retaining the services of the editor as a monthly basis contractor. **Motion;** Don Henderson, second Terry Etheridge to stop monthly newsletter and annual journal publications and move to quarterly publications starting January 2024. Motion caried. Unanimous
